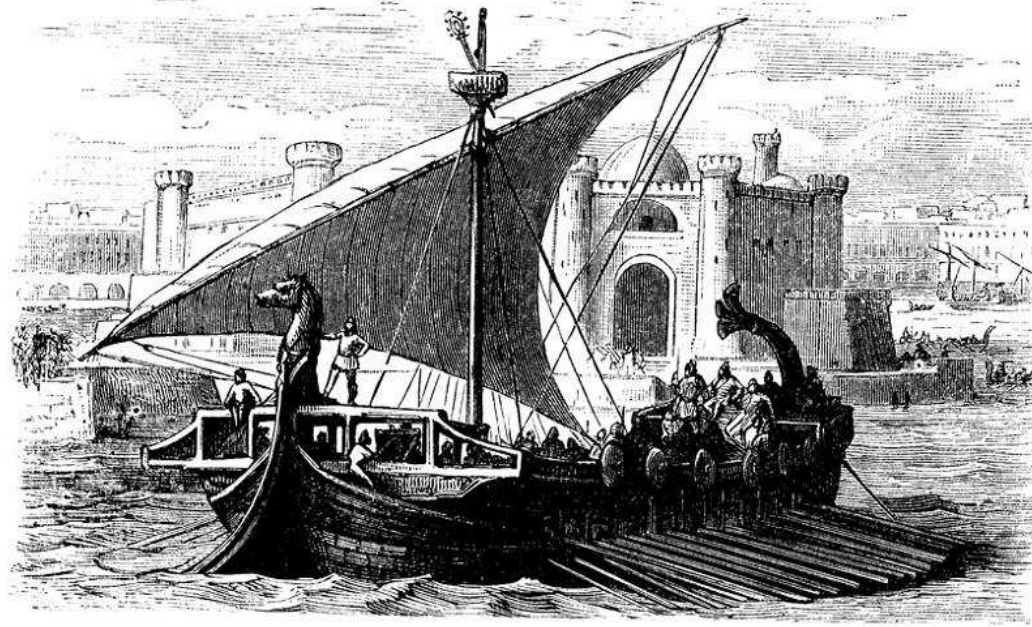

# The History of Cyprus as a Commercial Regional Hub

## Millenniums of Tradition

Since more than 3000 years, Cyprus has been an economic hub between the Middle East and North Africa on the one side, and Europe on the other side.

The Phoenicians established trade hubs in Cyprus, at the time of the ten “city-kingdoms”. The ancient Egyptians used Cyprus as a trade hub for their commercial interchanges with the Hittites, Phoenicians and other nations of the Eastern Mediterranean. Cyprus was known for its important olive oil production at that time, being a precious commodity for lamps, food and beauty. The Roman Empire further developed the olive oil production, and Cyprus became one of the main suppliers of olive oil for Rome.

# The History of Cyprus as a Commercial Regional Hub

## Millenniums of Tradition

During the Byzantine period, Emperor Justinian II agreed with Abd al-Malik ibn Marwan, the famous Umayyad Caliph, to rule Cyprus together, in order to mutually benefit from its central geographical position.

At the end of the last Crusade, Guy Lusignan founded the Frankish Kingdom of Cyprus (1192 – 1489), with Latin, and later French as official language, and Gothic cathedrals. Cyprus became an extremely rich commercial hub, controlling almost the entire trade in both directions between the East and the West.

# The History of Cyprus as a Commercial Regional Hub

## Millenniums of Tradition

The Frankish period came to an end with the influence of Venice, which ruled Cyprus from 1489 to 1571, utilising Cyprus as a commercial base for their trade between East and West, and vice versa.

After the rule of Venice, the Ottoman Empire ruled Cyprus 1570 to 1878, when Cyprus became a British colony. Both the Ottomans and the British benefited from Cyprus as a commercial hub.





# Cyprus as a Business Hub Today

## A business-friendly country serving the World

Cyprus is independent since the foundation of the Republic of Cyprus in 1960. Yet today, Cyprus benefits from its central location in the Eastern Mediterranean, being the most Eastern EU Member, closed to the Middle East and North Africa. Cyprus attracts companies from both, the Middle East and from Europe, as well as from the USA, choosing Cyprus as their regional headquarters.

Companies from the USA and Europe prefer Cyprus as a business location, or a business hub, to oversee and to manage their Middle East and North Africa (MENA) activities.





# Cyprus as a Business Hub Today

## Cyprus as a Gate to the EU

Companies from the Middle East, from India and from China are mainly benefiting from Cyprus as an “Entrance Gate to the EU” or as a beneficial jurisdiction for Holding Companies. Such companies are generally managing or operating their business activities in the European Union from Cyprus, benefiting from the advantages of Cyprus.

Another group of Middle East, Indian and Chinese companies prefer Cyprus to manage their investments in Europe, such as shareholding in medium-sized or large European industrial companies, or in substantial real estate objects.

- Cyprus maintains very good and intensive **diplomatic ties** with the countries of the **MENA** region.

- Cyprus is the **largest** global jurisdiction for **ship management** companies.
- Cyprus provides **very good infrastructure**, including communication infrastructure.
- The **direct implementation of EU Directives** in Cyprus provides many advantages.





# Some Tax Advantages of Cyprus

- Corporate tax is only 12,5 %, very low tonnage tax for ship-owning and shipping companies, 2,5 % on income from Intellectual Property (conditions apply, please read our specific page).
- No tax on disposal or trading of securities, including company shares.
- No tax on income from dividends on company level (for a period of four years).
- No withholding tax.
- No tax for International Trusts.
- No tax on dividend income of **non-domiciled individuals**.
- Full adoption of the EU-Parent-Subsidiary-Directive (dividend payments of the subsidiary to its parent are tax-exempted).
- **Full tax group relief** (profits of one group company are offset against losses of another group company).
- Offshore entities from other countries are allowed as shareholders.
- Rigid appliance of all relevant EU directives.

- for the protection of assets;
- for protection against personal bankruptcy;
- for the management of investments;
- for the maintenance of anonymity;
- for tax planning;
- for planning of succession;
- for pension schemes and other profit sharing;
- for charities,

to name a few.

Cyprus provides the most advantageous trust law available, and fully in line with EU legislation.



# Cyprus International Trusts and Trust Management

Cyprus International Trusts can be formed by any settlor who is not resident of Cyprus at the time of trust formation and the year after formation. The beneficiary of a Cyprus International Trusts shall also not be resident of Cyprus at the time of trust formation and the year after formation.

The income of Cyprus International Trusts is not subject to tax in Cyprus.

With its recent amendment in 2013, important rights are reserved to the settlor, who thus maintains specific control over a trust.

While settlor and beneficiaries remain anonym in the Cyprus Trust Registry, they must be disclosed to banks when opening bank accounts in the name of the Trust.
